The most recent data released by the School-Associated Violent Death Study covers the years 2014-2015 in which there were a total of 47 students, staff and other nonstudent school-associated violent deaths in the U.S. These deaths included 28 homicides, 17 suicides and two legal intervention deaths.

When instances of homicide and suicide of school-age students at school were combined, there was at least one student homicide or suicide at school for every 1.9 million students enrolled.

The majority of this conduct could easily be avoided by a simple voice that speaks on behalf of the victim.

Many teenagers go through high school with the mentality that they cannot talk to adults about issues.

This is the mentality of many students today. The desire to speak up is within them, but this desire is too often silenced by the voice of fear.
